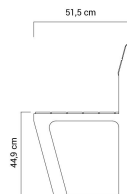
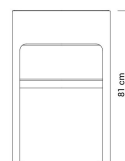
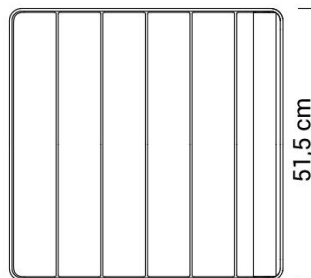
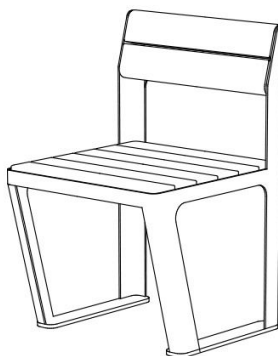
### Methods of installation

## DESCRIPTION

The Scandik chair with backrest is a single seat recommended for combination with a chess table or a solar station. It is a modern city chair designed with attention to the smallest details. It is made of steel and wood. We can choose stainless steel or carbon powder coated in any RAL colour. Wood in our offer for domestic wood (pine, spruce) or exotic wood (meranti, sapela and iroko). On special request we make furniture from any type of wood indicated. We can optionally replace the wood with HPL laminate or steel.
