
## **DESCRIPTION**

Contemporary, durable information boards with slightly rounded edges. Designed in four universal sizes of printing/etching area. Printing areas are standard A4, B2 and B1 formats.

The boards are available in four sizes from S to XL. The S,M models are designed to present short, concise information. They can be used as direction signs. L and XL models are designed to present more extensive content (e.g. maps of tourist trails, cities, airports, stations). The steel construction guarantees resistance to weather conditions and long life of the boards. The structure can be made of stainless or carbon steel, galvanised and powder coated in the RAL colour indicated by the customer.

The boards are mounted to the ground by bolted to the concrete ground with anchors.
