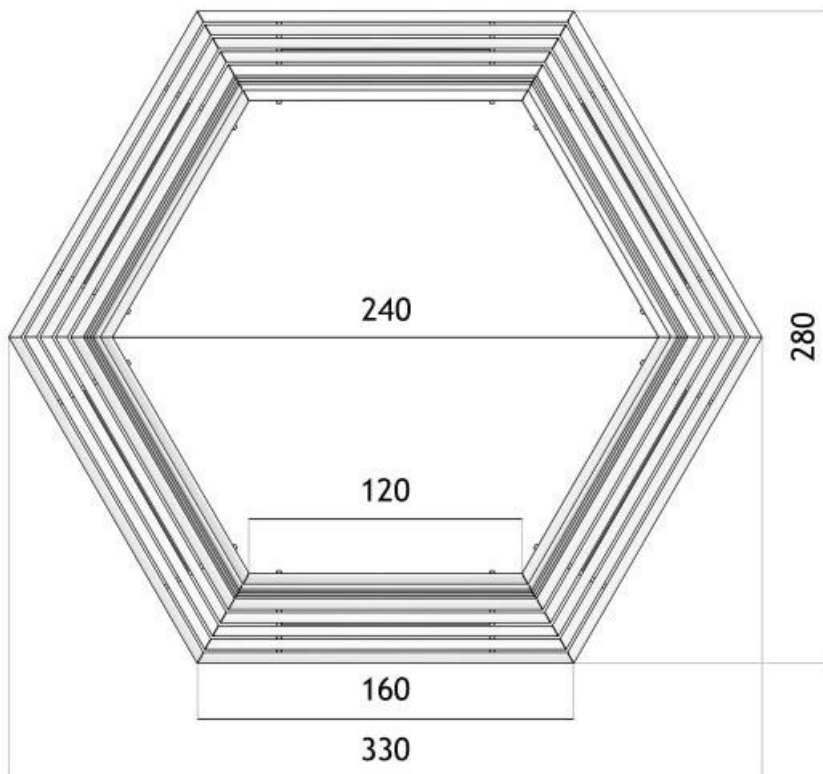

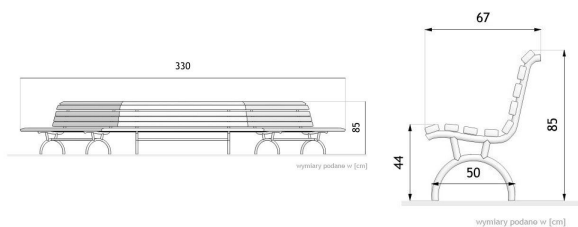
DESCRIPTION

The main construction of 02.286 bench is made of carbon steel. 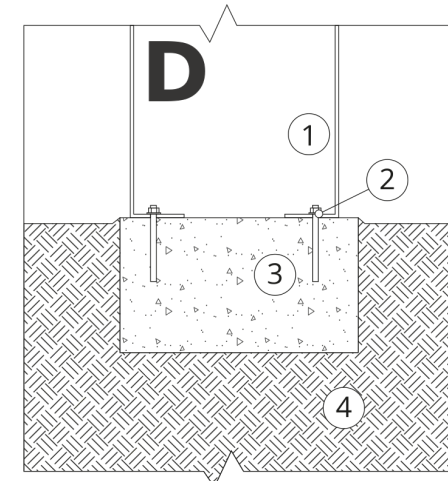
